I hereby agree on the _____ day of _____ Year 2010 to breed the mare (name) _____, registration # _____ to the stallion **Colonels Lil Gun**, AQHA Registration #4561713, APHA #407166 for the 2010 breeding season.

This Mare will: Carry the foal Embryo Transfer

- The stallion fee is \$2000.00 which includes a non-refundable booking fee of \$500.00 which is payable upon execution of this contract. **The balance of the stallion fee must be paid ten (10) days prior to shipping.** There are additional charges, as listed in the fee schedule above, for each additional shipment.
- A copy of the mare registration certificate must accompany this contract. The owner on the registration certificate will be the owner recorded on the Stallion Breeding Report.
- Double PR Ranch collection days are Monday, Wednesday and Friday. Mare owner will notify Stallion Manager or Double PR Ranch when mare comes into heat. Have your breeding veterinarian contact the Stallion Manager at least two days PRIOR to when semen will be needed. **Cancel orders for Semen by 8:00 a.m. on collection day.** Requests are on a first come first serve basis.
- Stallion Manager and/or Double PR Ranch are not responsible for any untimely arrival or condition of transported cooled semen. Once it leaves our custody we have no control. Shipping charges are subject to change at anytime.
- Live Foal Guarantee - A Live foal is described as a newborn foal, resulting from this breeding, stands and nurses without assistance for 24 hours.
 - If the mare fails to produce a live foal from the breeding granted by this agreement, the Mare Owner may rebreed the Mare during the subsequent breeding season. Only if the **Stallion Manager is notified within ten (10) days and receives a statement confirming that the mare did not produce a live foal.** There is a re-breed charge as stated in the Fee Schedule above. A substitute mare, accepted by the Stallion Manager, may be used **ONLY** if the original mare is deceased or deemed unfit for breeding.
 - Confirmation of pregnancy of the mare at 60 days must be submitted in writing from a veterinarian or receiving station.
- The LIVE FOAL GUARANTEE IN THIS CONTRACT IS NON-TRANSFERABLE AND NON-ASSIGNABLE should the mare be sold or otherwise disposed of prior to the birth of the foal, the live foal guarantee shall be void. However, the Stallion Manager may at his discretion upon application and payment of a new booking fee, continue to honor the live foal guarantee granted to the original owner. In the event that the Stallion Manager agrees to the transfer or assignment of the "live foal guarantee", rights under the terms of the contract, then the new owner agrees to be bound by all terms and conditions hereof, insofar as the same may then be applicable.
